# DAY PROGRAMS FOR PERSONS WITH INTELLECTUAL OR DEVELOPMENTAL DISABILITIES

#### 1. Day Activity and Health Services (DAHS)

Funded by Medicaid

Must have a medical diagnosis

Adult day care for individuals who are geriatric or disabled

#### 2. Day Habilitation Programs

Funded by Program Fees. General Revenue funds from the Alamo Local Authority, HCS and ICFID.

Funding can be used to pay program fees or private pay.

Must have a diagnosis of intellectual disability and/or autism or a developmental disability. Provides an array of learning opportunities and contract work

#### 3. Sheltered Workshops

Funded by Program Fees
ICFID or HCS Funding or private pay.
Must have a diagnosis of an intellectual disability, autism or developmental disability
Contract work

#### 4. Supported Employment/Employment

Funded by Program Fees. Department of Assistive and Rehabilitative Services (DARS) and General Revenue funds from the Alamo Local Authority can be used to pay the fees.

Provides Job placement and Job coaching

#### 5. Work Enclaves/Team

## Day Activity and Health Services (DAHS):

#### What is a DAHS program?

A DAHS program is day programming for adults with Intellectual Disabilities and and/or physical disabilities. The objectives of the program are to provide for the physical and medical needs of clients, provide training in life skills, provide leisure time and maintain a safe, clean and stimulating environment. Eligible participants must have a functional disability and a medical diagnosis that requires monitoring by a licensed nurse. Services include: grooming, transfer and ambulating, toileting, feeding, fluid intake, special diets, medication, exercises, behavior management and recreation.

#### How is a DAHS program funded?

The individual must be a Medicaid recipient or be financially eligible for services. Private pay is also an option.

#### **Vocational Services:**

#### What are vocational services?

There are 3 types of vocational opportunities for individuals with Intellectual Disabilities. *Competitive employment* is simply working at a traditional job in the community with minimal supports. *Supported employment* is paid, competitive employment for people who have severe disabilities and a demonstrated inability to gain and maintain traditional employment. Supported employment includes supports like job coaches and occurs in a variety of normal integrated business environments. *Sheltered workshops* are programs that provide opportunities for individuals to be paid via contract work within an agency (i.e. The Arc of San Antonio, The Unicorn Center, Alternative Business Services, CHCS Employment Connections)

#### How are vocational services funded?

Funding for vocational programs can come from several resources. The Department of Assistive and Rehabilitative Services may provide funding *if* the individual has expectancy for competitive work. For individuals with Intellectual Disabilities, The Alamo Local Authority may fund supported employment services.

#### What is a Day Habilitation program?

Day Habilitation programs are life skills building programs (i.e. cooking, self-care, nutrition) that focus on enhancing lives and promoting independence. Some participants have opportunities to improve work readiness through contract work.

#### How is a Day Habilitation program funded?

Day Habilitation services can be funded by ICF-MR residential programs, the Home Community Services (HCS) and Community Living Assisted and Support Services (CLASS) Medicaid Waiver Program, Texas Home Living Waiver Funds, General Revenue Funds or private pay.

The mission statement of the Extended Employment Program of Unicorn Centers provides the foundation for the establishment of a "real work" environment. All customers are treated in a manner consistent with a "real job." Each customer is assigned a supervisor, given breaks, and production demands within their ability, and paid appropriately for all work.

Certified by the department of labor, participants work at Unicorn on subcontracted jobs in cooperation with area businesses. Often this is the first real experience many have had "doing a job." 


